Dear Mr. Hernandez,

The Bel Air Beverly Crest Planning and Land Use Committee, at its April 12, 2016 meeting heard a project presentation for the four house development and road construction at 1800, 1806, 1812, 1818 Crisler Way. The Committee voted to continue the project as the previously permitted drawings and 3-D renderings in the presentation were not coordinated. In attendance were seventeen neighbors and a lawyer representing other neighbors below the project site, they testified in opposition to the project. There was one neighbor in favor of the project in attendance. The Applicant Robert Anderson (CAC Development) and Representative Erika Iverson (Rosenheim & Associates) presented the project and answered questions. The biggest concerns of the neighbors are the poor access to the undeveloped street, the amount of dirt export and no haul route; CEQA and cumulative impacts, no parking or staging areas, construction logistics, the issues with the previously approved plans by LADBS, the access for the fire department, and the reality of numerous large construction vehicles blocking access over a long period of time, and other related safety issues.

Please note that in late 2016, the BABCNC has a standing policy for applicants with continued projects to reschedule a meeting and provide additional or requested information, if they do not return the standing vote will be to deny the project.
