- 1. Call to Order: Robin Greenberg called the meeting to order at 7:05 pm.
- 2. Roll Call (quorum 15) Robin called the roll with 21 present initially; quorum met. Luis arrived at 7:27, with 22 present and 10 absent. Michael Kemp arrived at 7:32 with 23 present and 9 absent.
- 3. Pledge of Allegiance
- 4. Approval of <u>May 23, 2018 Agenda</u> (per Bylaws, Article VIII, Section 2) <u>Moved</u> by Kathy C, <u>seconded</u> by Larry; <u>21 yes</u>; <u>0 no</u>; <u>0 abstentions</u> <u>Approved</u>
- 5. Approval of <u>April 25, 2018 Minutes</u> (Attachment A) Copy was circulated with agenda. <u>Moved</u> by Larry; <u>seconded</u> by Maureen S.; <u>21 yes</u>; <u>0 no</u>; <u>2 abstentions</u>: Travis & André. <u>Approved</u>.
- 6. Public Comment: Patricia Hearst: 1) Patricia met a gentleman with L.A. County West Vector & Vector-Borne Disease Control District, who works with bees, mosquitos, insects & vectors; they remove beehives free of charge. 2) Patricia would like to bring back the fire-prevention motion on weed-whackers.

**Anh Ngyun, Californians for Responsible Housing** spoke on concerns about a November 2018 ballot initiative to repeal Costa Hawkins; noting, if repealed, would give cities wide latitude to impose rent control even to single-family homes, concerned that "housing policy should not be done by the ballot" and about potential decrease in property values; requests that we have her back for a presentation.

Alfred Coletta, Candidate for Judicial Seat #4, which is vacant. He is a Deputy District Attorney for 30 years, among other things. Go to <u>www.Colettaforjudge.com</u>

Tony Tucci showed a video and asked for a Yes on Prop 68 to protect water, parks and natural resources.

#### **Reports of Officers**

#### 7. President's Report – Robin Greenberg

- a. Representatives of Elected Officials and Agencies (Updates & Discussion)
  - i. Janet Turner, Representative of Congressman Ted Lieu, 33<sup>rd</sup> District Janet expressed the Congressman's best wishes and gave updates: Liberty Canyon Wildlife

Crossing EIR is complete; they've come to agreements with the City of Agoura Hills; project is green-lighted but must be privately financed; it will have an overpass with a little underpass. The Congressman co-sponsored the Music Modernization Act and the VA Mission Act, sponsored the Hack Your State Department Act, co-sponsored Robo-Cop Act, which has just been proposed and the FAA Reauthorization Bill, provision to reduce noise pollution. Chuck and Larry suggested logging into your telephone service account to find the "NoMoRoBo" option link.

ii. Faisal Alserri, Planning Deputy for CD-5 Councilmember Paul Koretz – Faisal returned; he will be leaving CD5. He noted a few new legislative amendments that came out of suggestions from this NC including but not limited to the prohibition against decks over 1,000 square feet from Don, Robert & a few others, when they had a case requesting a 30,000 sf deck; initiated motion to amend the Bel Air Overlay; for the first time ever, considering a haul route start date came out of this NC. Gurmet is on Family Leave for another month. Faisal will be leaving his post and joining a real estate firm in the desert. CD5 is in final stages of hiring a new planner. CM Koretz has almost five years to push forward his legacy planning policies including the Ridgeline Ordinance, which he stated we are in the "final stretch" of. He anticipates his last day to be June 15<sup>th</sup>. Pamela asked about Benedict Cyn development. Chuck wished him luck and asked him to tell Gurmet we miss her. Larry asked about increased capacity for new water pipeline project. Nickie noted that the project is going very smoothly; they're adding fire hydrants and there is no controversy. Mike and the Board gave Faisal their thanks. He offered pro bono consulting and complimented this board for all that it has done, altering the city's code.

#### iii. Daniel Eyal, Neighborhood Advocate for CD-4 Councilmember David Ryu

Daniel introduced Emma Howard, CD4's new Planning Deputy, and gave brief updates: Today, the Transportation Committee passed a ban on open-air tour buses using loudspeakers; it goes to full Council in coming weeks; expects it to pass. On Monday, City Council signed off on the final nearly 10 billion dollar budget for 2018-2019. There will be an increase in LAFD budget to hire more fire fighters; ten million dollar increase to fund sidewalk repairs; increase in funds for homelessness including enforcement of encampment laws; Council unanimously voted to regulate short-term rentals (STRs). CM Ryu had his party-house amendment, and, as part of STR, there are penalties for violating the ordinance; it goes back to committees; City Attorney will draft ordinance for final votes. Dan Love asked if David Ryu supports Paul Koretz's petition to make amendments for Bel Air Overlay Zone, which will limit party decks on party houses, to which Emma noted that they do support this. Robin noted that Stephanie, Cathy Wayne and Robin attended David Ryu's Neighborhood Council forum, which was a success.

#### iv. Emma Howard, Planning Deputy for CD-4 Councilmember David Ryu -

- Jamie, Tony and the Board welcomed Emma, who was a Planner with LA County. - Irene asked about the West Sherman Oaks Hills Transportation Signalization Change, to which Daniel noted that that they have implemented traffic mitigations, directly parallel to Sepulveda Blvd., for narrow streets, which have been used as commuter thoroughfares. Working with the Dept. of Transportation, starting on May 15<sup>th</sup>, they installed 14 traffic mitigations on select streets which qualify for restrictions due to narrowness & being substandard, such as no left turns 7-9am. On Woodcliff, they're adding a right-turn only at Valley Vista; SB restrictions are 7-9am; the only NB restriction is at Woodcliff @ ?, no right 4pm-7pm; SB access to Cody Rd which gets to Mulholland is restricted 7-9am.

v. Semee Park, Director of Neighborhood Council Operations – Semee was present to answer questions as needed. Robin thanked Semee for coming to our recent clean up.

Jamie was to present list of mitigations to Nicole. PLU Committee Motion: That we advance this to the full board and present additional conditions of approval that would be necessary to support the project. 11 yes; 0 no; 0 abstentions; Passed.

Chris Parker and Nicole Kuklok-Waldman presented; Mr. Ayoub and owner, Mr. Byrne, were also present. Nicole had conversations with Jamie, returned asking for approvals for variance for driveway and front-yard setback, a ZAD for retaining walls integrated into part of the house, two exposed retaining walls very low; one RW required by DWP, a soil nail wall. Discussed street improvement for Blue Heights. They are asking for a soil nail wall to retain an unstable grade, and bring to standard width; says they agreed to community concerns and are working with MRCA to create a native life passageway for critters to get around the property. They were asked to comply with Sunset Doheny construction terms that they agreed to and addressed concerns of proposed condition as to soil nail wall. Blue Heights is an emergency access point, Kirkwood bowl's secondary access; street is substandard; they are confident that this will address it. They report that the house is subject to the old BHO, including size of basement.

Jamie noted that the PLU committee didn't take an action, expressed issues; hearing is tomorrow at 10:30 am. <u>Main issues</u>: Not wanting that road blocked; the 10,000 cy soil being removed; need specialized conditions including staging and parking. They discussed soil nail wall. They're doing work on two parcels; "almost like a ridgeline..." The wall will stabilize the hillside; they did an MND; expressed a willingness to preserve portions of the property for wildlife; discussed ratios of replacing protected trees. Biggest issue remains that this is a 20,000 square foot house. It has a 9,000 square foot basement, two stories over the basement. Jamie related that he has spoken with the community, which does not feel comfortable with a house of that size. Jamie referenced the Community Plan. The other issue is the HCR, while there is a 6,000 cy max.

The question remains the size of the house. Stephanie looked at the house size, with a 1,000 foot radius and 201 homes average 3,100 square feet. There are only three houses over 10,000 square feet. Concern when looking at the General Plan. This property says RE11, but site is R1, which would affect the height envelope. She looked for overall height: top of roof to basement level is 45 feet, but measure by BHO 5' offset off the lowest point to the top of the roof. There is n ZAA listed in their request. It is over-height. They didn't list a ZAA for that in their request. Dan Love asked about height. Ameen noted that it is under, even with the 5-foot offset and believes they met the requirements, noting that the roof from the street is 9 feet above grade. It's on a one-acre site and they're meeting a 33% ratio.

- Travis asked about the two protected trees: Walnut 8-10 feet tall, grouping with their landscape plan. **Motion**: To **oppose** the project on the legal basis that the MND is inadequate because it didn't assess the visual/aesthetic impacts of the soil nail wall, since it's an undeveloped ridgeline; and being concerned about project with regard to the community plan.

<u>Moved</u> by Jamie; <u>seconded</u> by Luis. Discussion was held; <u>19 ves; 0 no; 4 abstentions</u>: Chuck, Cathy K, André & Irene; <u>Passed.</u>
