- 1. Call to Order & Roll Call (Quorum 15) Robin Greenberg called the meeting together at 7:03 pm. Roll was called by Robert Ringler, with 26 board members present initially. Patricia Murphy was seated to newly vacant North of Sunset seat; shortly thereafter there was a total of 31 board members present and two absent.
- 2. <u>Motion</u>: Approval of July 22, 2020 AGENDA (per Bylaws, Article VIII, Section 2) <u>Moved:</u> Cathy; <u>Seconded</u>: Larry; <u>26 yes</u>; 0 no; <u>0 abstentions; approved</u>
- <u>Motion</u>: Approval of <u>May 28, 2020</u> & <u>June 24, 2020</u> Meeting MINUTES (Attachment A) <u>Moved</u>: Marcia; <u>Seconded</u>: Bob. Larry noted he communicated to Cathy addition for June 24<sup>th</sup> minutes to reflect very short conversation he had with Jarrett re: resurfacing Sepulveda, Northbound Getty Center off ramp. Heather noted that she called Cathy and clarified comments attributed to her in item #18 of the June 24<sup>th</sup> minutes. <u>27 yes</u>; <u>0 no; 0 abstentions.</u> May 28<sup>th</sup> minutes were approved as written & June 24<sup>th</sup> minutes approved as amended.

### 4. General Public Comments:

Philip Enderwood was disappointed with the City Attorney's office for not taking a stance on the Hadid property.

**Wendy Morris** commented on our votes for officers being public. Larry Leisten explained that elections for officers held by a neighborhood council not done through public- or city-administered election must be done at a neighborhood council meeting and must be open and transparent and that any member of the public or board could request reading of the ballot. Cathy Wayne and Nickie Miner noted that in the past we never knew who was voting for whom. Robert Ringler commented that the executive committee decided, the board did not decide.

### Julien Antelin, our new Neighborhood Empowerment Advocate (NEA) from the Department of

**Neighborhood Empowerment (DONE)** introduced himself and confirmed that election of officers, (*not through a public- or city-administered election*) can be made on a ballot; it's not a secret vote; someone can request the results and who voted from whom. In the past, if you were using a ballot you had to write your name on the ballot and who you were voting for; the minutes do <u>not</u> have to reflect the vote of each individual, and there is no retention policy so you don't have to keep the ballots for certain period of time. Larry referenced a letter from City Attorney, Michael Feuer, indicating, under "Special Elections, Initiatives, Referenda, Officer Elections," that votes must be recorded openly. He asked that the board accept what we've done here and the endorsement by Julien, noting he had advised the board based on his best knowledge and opinion from the City Attorney's office.

**Mindy Mann** reported good news about Wildlife Pilot Study not being defunded; the staff will continue; Santa Monica Mountains need to be protected. Robin commended Paul Koretz's and this NC's support for this.

## 5. <u>Representatives of Elected Officials & City Agencies</u>

- Council District 4 Councilmember David Ryu noted that they are dealing with police reform, budget issues, corruption issues, and the lingering first pandemic of homelessness. His website contains a COVID-related page, discusses all those topics, and includes his position papers & resources. Councilmember Ryu responded to request to address issue that DONE and City Attorney advised neighborhood councils against speaking with non-city groups, and that the only person you can talk to is the City Council and the Mayor. He thinks this is ridiculous, that you have a voice, and that his Chief of Staff seeking clarification on this from the City Attorney & DONE. Robert Ringler raised the issue about the difference between board members representing themselves or the board. Bob Schlesinger noted that we have an item on this on tonight's agenda to add to our standing rules.

Jamie Hall asked CM Ryu about his proposal to change the City Charter by adding more Councilmembers to the City Council, to which CM Ryu explained that back in 1925, each Councilmember (CM) represented 80,000 people and the structure never changed. He noted that NYC has 51 CMs & Chicago has 50. He is concerned about lack of representation, the enormous power and opportunities for corruption within Council and would like to use this opportunity to fix it.

Madelyn Taras, Representative for Council Member David Ryu, CD4 greeted the board via Zoom.
Jarrett Thompson, Representative for Council Member Paul Koretz, CD5 was also present via Zoom.

- Senior Lead Officer, Brett Cohen, introduced himself in the absence of SLO Ralph Sanchez. (424) 215-4754 <u>40760@lapd.online</u> Email preferred. SLO Brett Cohen noted that he is from the Hollywood Community Police Station, covering area east of Doheny. He asked that you email him as to party houses. Ellen asked if we can get night traffic enforcement 11pm-3am. He responded, yes, but noted that they disbanded the unit due to limited resources & are looking for resources; he'll keep her apprised of that within the next week. Philip asked if there was any new information on the shots fired on the 1800 block of Nichols Canyon July 12<sup>th</sup> @ 4:30 a.m., to which Officer Cohen responded yes; info will be released on this in the next few days.

- Erin Seinfeld, Rep for County Supervisor, Sheila Kuehl, covers Beverly Crest & Zac Gaidzik covers Bel Air. Erin reported that the night before, the supervisors had a board meeting, and acting on a motion by Supervisor, Mark Ridley Thomas, the Board of Supervisors unanimously approved to establish an anti-racist LA County policy agenda, the motion called on the board to declare that racism is a matter of public health; called for making legislative policy program changes to prioritize physical and mental health, housing, employment, public safety and justice, to act in an equitable way for the black community, and calls to track progress and report annually on the state of black LA County.

The Board approved the 1.22 billion dollar CARES Act spending package to fund a broad range of essential services and relief measures to assist County residents and business affected by the COVID-19 crisis, including but not limited to: 656 million dollars for public health measures including testing and contact tracing; 200 million for financial support for residents in the form of assistance for rent relief, food and child care, 160 million for grants to support small businesses and 150 million to support the County work force in response to the emergency including for disaster service workers and personal protective equipment for employees.

The Board of Supervisors voted 4:1 to put a measure on the November ballot to permanently require at least 10% of the County's unrestricted General Fund dollars to go towards social service and racial justice programs. The motion was co-authored by Supervisor Kuehl. It is the first step; County staff must draft the ballot measure, and the Supervisors need to vote on it twice more in the next two weeks before it gets placed on the ballot. At that point, voters will be asked to approve the move through a change County charter. Money would be redirected to areas including job training, rent assistance, affordable housing and mental health services. https://supervisorkuehl.com/wp-content/uploads/2020/07/FACT-SHEET-L.A.-County-CARES-Act-Coronavirus-Relief-Fund-Spending-Plan\_02.pdf

- Veronica de la Cruz, Neighborhood Prosecutor for WLA Police Station, came to listen and check in with us.

# 6. <u>Reports of Officers</u>

a) President's Report – Robin Greenberg noted that it is a pleasure to be on a NC where everyone wants to do something!

- i. <u>Appointment to Fill a Newly-Created Vacancy for North of Sunset District</u>: BABCNC Board appointed Patricia Murphy, as <u>moved</u> by Ellen; <u>seconded</u> by Larry; <u>27/0/0</u>.
- ii. <u>Discussion & Possible Motion to Establish Default Committee Size Standing Rule</u> (Attachment B) Larry noted as to issue of requiring notice of joint meeting of Board & committee when majority of Board quorum is present at committee meeting, notwithstanding his disagreement with this opinion, where possible he advises Board to comply, but not to abide in circumstances that merit committee size in excess of majority of quorum and not noticing joint meeting.

**Motion**: Because 8 is a majority of the board, default size would be 11 with no more than 7 board members on a committee. Larry **moved**; Bob **seconded**; extensive discussion was held. Larry noted that the motion to establish maximum at 11 members is just a base case, subject to adjustment to Board discussion.

Chuck made a case for the Emergency Preparedness Committee having more than 11 members as it does outreach. His committee currently has 13 members; however, Michael Schlenker is unable to continue so will go down to 12. He does not feel that 11 is good for outreach. Larry noted this is establishing a "default" size. He'd support a waiver from the requirement for 11 total in this case based on Chuck's argument. Larry noted this number is not cast in stone; it's a starting point; we don't want committees to become large and burdensome. Chuck feels 14 is a good number. Larry **moved, as an amendment**, to include 14 for the EP Committee.

André opined he if there is no problem, don't fix it. Irene, as Chair of Traffic Committee, wants to hear from people to solve problems, not limit ourselves to a small committee. Julien related that it is the Department's recommendation, regarding board members, but <u>there is no limit of community members in general</u>. People with the power to vote is separate. Roll call vote was taken with <u>8 yes; 21 no; 1 abstention; 3 absent; motion failed</u>

- b) Vice President's Report Nickie Miner related that it has been an honor to be a part of this neighborhood council and congratulated those who get into the next two newly created VP positions.

### b. <u>10430 W. OLETHA LN. ZA-2019-1222-ZV-ZAD-ZAA ENV-2019-1223-CE</u>

**Project Description:** CONSTRUCTION OF A NEW 30 FEET HIGH 3-STORY ONE-FAMILY DWELLING AND ATTACHED ONE-CAR GARAGE.

**Requested Entitlement:** A NEW 3-STORY, 30 FEET HIGH ONE-FAMILY RESIDENCE IN THE RE15-1-HCR ZONE, WITH REQUESTS FOR:

- A ZONE VARIANCE PURSUANT TO LAMC SECTION 12.27 TO ALLOW CONSTRUCTION OF A ONE-CAR GARAGE IN LIEU OF THE REQUIRED TWO COVERED PARKING SPACES FOR A ONE-FAMILY RESIDENCE AND

- TO ALLOW A HEIGHT OF 31 FEET AND 3 INCHES IN LIEU OF THE PERMITTED 24 FEET WITHIN THE FIRST 20 FEET FROM THE FRONT PROPERTY LINE AS MEASURED FROM THE ADJOING STREET CENTER LINE;

- A ZONING ADMINISTRATOR DETERMINATION PURSUANT TO LAMC SECTION 12.24.X.28 FOR A NEW RESIDENCE: ON A LOT FRONTING ON A STREET IMPROVED TO LESS THAN 20 FEET WIDE, ON A LOT WHERE VEHICULAR ACCESS FROM THE LOT TO THE BOUNDARY OF THE HILLSIDE AREA IS ON STREETS NOT CONTINUOUSLY IMPROVED TO A MINIMUM OF 20 FEET WIDE; AND, - A ZONING ADMINISTRATOR ADJUSTMENT PURSUANT TO LAMC SECTION 12.28 TO ALLOW FOR AN UP TO 10% INCREASE IN MAXIMUM RFA.

Applicant: JONATHAN KOZUN Contractor on parking & staging: Beka Saldadze

<u>PLU Committee Motion</u>: To approve the project with the condition that there is a civil engineer hired to lay out the property frontage to ensure there is some way of parking and/or ask for the two tandem spots for the compact cars because it could set a bad precedent to have a one-car covered space for a lot like this. Approve with the condition that a plan is provided to both allow for parking in front of the property with an apron and a curb, that they request the ZA to allow for tandem parking for two compact vehicles, and that they improve the road along property frontage. <u>Moved</u> by Stephanie; <u>seconded</u> by Bob. <u>6 yes; 1 no; 4 abstentions; passed</u>.

Stephanie reviewed the entitlement requests, and noted that it is a difficult lot. Jonathan Kozun and Beka Saldadze were present to answer questions. Presenter related that it will be 1,533 square feet. Yves noted that parking is extremely limited on that street and he is against having one-car parking. The city requires two cars parked. Stephanie discussed difference of having a compact and standard space being 3 feet; 7-1/2' for compact and 8' for standard. Travis asked if they have heard from representatives from Beverly Glen. Robert Ringler noted that he and Dan Palmer live in Beverly Glen. People now rent out rooms, have kids, it's a mess on the side streets and there is a speed problem and DUI problem. Dan agreed with Robert; he lives on a steep narrow road in Beverly Glen, and says that is difficult to park on the street, trash days are chaotic, it's only 3' more to the hillside, and he thinks they ought to have full-space parking. Jonathan noted he wanted to do tandem; standard and compact couldn't cover it; he could fit two compact in as a tandem.

Larry reviewed the condition in the PLU Committee motion to hire a civil engineer to lay out property frontage, and asked, what if a civil engineer cannot lay out these parking spaces as hoped for? He defers to people who live locally. Jonathan noted that he has contacted some of the neighbors and three have signed off: Dominique, Nate & Christiana. Nickie opined that denying this project won't fix the parking problem; the Land Use Committee felt this was a project that they can support, to which Stephanie added, support with conditions that include property frontage approved by Bureau of Engineering, two compact in lieu of one standard/one compact parking space. **15 yes; 5 no; 10 abstentions; 3 absent; passed.**

a) <u>Possible Land Use Motion</u>: Whereas, the statewide Covid-19 emergency has reduced the action calendar time frame of the California State Legislature, and thus greatly reduced the ability of California's citizens to weigh in on legislation having to do with land use planning;

- Whereas the proposed Atkins Housing Package of bills has not been sufficiently vetted for integration with previously approved Regional Housing Needs Assessment legislation, which modernized the methodology for anticipating growth in the state;

- Whereas communities continue to urge greater accountability, fairness, transparency, and responsiveness from public officials in the area of land use planning;

- Whereas the proposed Atkins Housing Package of bills has *not* been sufficiently vetted for growth induced impacts and substantial hidden state mandated costs upon:

- Local General Plans and Community Plans;

- Communities in environmentally sensitive areas such as High Fire Hazard zones; Coastal zones; Earthquake fault zones and others as listed in the California Environmental Quality Act [CEQA];
- Traditionally underserved communities and the impact on displacement in those areas;

- Critical local infrastructures for the public health, welfare and safety;

BABCNC recommends a postponement of action on this suite of housing bills until such time as the previously enacted 2018 and 2019 housing legislation has been given a chance to increase housing production as promised. *[This motion passed unanimously in WRAC, after substantive discussion and some amendment.]* 

In addition, per the recommendation of the Hillside Federation, the BABCNC urges you to factor the elevated risk to persons and property due to wildfire into your consideration of all measures intended to increase housing, and to protect residents from the unintended consequences of allowing increased development and residential density in very high fire hazard severity zones and wild land-urban interface/intermix area. (Attachment F)

b) <u>Discussion & Possible Motion</u>: BABCNC insists that Neighborhood Councils are not prohibited from communicating with non-City of Los Angeles government representatives and/or staff not with entities other than those within the City, regarding issues impacting their neighborhoods; and that Neighborhood Councils are free to discuss any issues of local concern. [Motion passed unanimously in WRAC.]

c) <u>WRAC Membership Dues</u>: <u>Discussion & Possible Motion</u>: Support concept that each member organization contribute \$250 annually to cover WRAC expenses, including website design and hosting, event fees and other incidental operating expenses.
