- 1. Call to Order/Roll Call: Board President Greenberg called the meeting to order at 7:00pm. Secretary Ringler called the roll with 25 members present initially; Dan Palmer arrived @ 7:08pm, Dr. Garfield @ 7:11pm, Heather Roy @ 7:20pm for a total of 28 present and 5 absent.

# 3. Public Comments:

**Maureen Levinson**, Bel Air Resident, requested that the board agendize community impact statements (CISs) for motions in Council File #20-1174, #20-1175, #20-1012, #20-1170, pertaining to home sharing and land use issues. (Of note, #20-1170 is on this evening's agenda, Item #20 below and action was taken on it.)

**André Stojka** related that the lease is up at the Bel Air Postal Center. The people who operate the center are in negotiation. They have been very generous in posting our agendas. It would be helpful to find out who the owners are or who they are negotiating with.

**Robert Ringler**: Cautionary note for those who live on a side street: There are videos of people going up and down the side streets stealing mail, all occurring at night.

### 4. Guest Speakers & Representatives of Elected Officials & City Agencies

a) **Guest Speaker, District 50 Assembly Member Richard Bloom**: Board President Greenberg introduced the Assembly Member. Richard Bloom noted that he has been working for five years on curtailing the use of anticoagulant rodenticides, now on the Governor's desk; believes it will be signed and a moratorium placed on their use while undergoing pesticide regulation review process. He noted that another mountain lion was killed today on the 101 Freeway. He has a couple of other bills on the governor's desk.

One of his major responsibilities is chairing "Budget Subcommittee #3" with jurisdiction and oversight over transportation and natural resources; includes the Natural Resource agency, Cal Fire, Cal Trans and other important agencies employing tens of thousands of Californians, providing very important services to the State. He conducts hearings throughout the budget process.

As to wildfires, he noted need to confront not doing enough in area of fire prevention and protecting properties. They will have an oversight- and informational-hearing in a few weeks in Sacramento to focus on that, to help formulate a response, including difference on how woodland forests and chaparral areas are addressed.

Q&A was held which included but was not limited to the following:

BABCNC Land Use Chair R. Schlesinger asked the Assembly Member about the 9 housing bills, to which Richard Bloom pointed out that he feels very strongly about need to find ways to build new housing; that this is a supply issue on the market rate and affordable housing side. One of the bills that he voted no on, which will likely be back, would have allowed people who live on lots that could be divided in half to build a duplex plus accessory dwelling unit (ADU) on each of the two lots, increasing units for a single family residence to 6 units. (He noted that most hillside lots wouldn't apply.)

BABCNC Bylaws, Rules & Elections Chair LM Leisten asked about California redemption centers that have closed. Richard Bloom acknowledged that recycling centers are closing and they haven't found the solution to getting them back open. He noted that this is an environmental disaster; we need to recycle plastics and reduce use of plastics dramatically, glass and aluminum are also not being recycled to the extent they need to be.

BABCNC Emergency Preparedness Chair C. Maginnis expressed appreciation for Tim Pershing, the Assembly Member's Representative. Richard Bloom noted that the budget hearing will discuss better funding for emergency preparedness regarding fire and noted that we are also at risk for earthquakes 12 months of the year.

BABCNC Representative of Bel Air Ridge Association A. Stojka asked if he will push for additional water supplies in SoCal as they push for additional housing, to which the Assembly Member focused on need for better water conservation. He noted that we started to do a good job on water conservation during the drought but moving water around in the state accounts for 20% of energy, is extremely expensive, inefficient and uses too many resources. He acknowledged the need to build infrastructure to support the housing we need to build.

BABCNC VP of Legislative Affairs J. Hall thanked him for sponsoring the anti-rodenticide bill. He asked the Assembly Member to support continuing to meet virtually in the future, to which the Richard Bloom acknowledged benefits of meeting on Zoom, with the caveat that the Brown Act is for open meetings to be respected. He hopes for a balance and believes there may be a requirement for at least a couple of meetings a year in which people meet in person.

BABCNC Custodian of Open Spaces Representative T. Longcore, Ph.D. thanked him for all the work he does. Dr. Longcore related that he has worked in environmental planning for a long time, was one of the architects of the <u>Green Visions for 21<sup>st</sup> Century Southern California</u> that balanced storm water management, conservation, and access for open space, later used as a template for LA County Prop A. In the context that he has worked professionally on this, Dr. Longcore thinks it is completely counterproductive and not welcome for the Legislature to get into trying to zone cities from Sacramento because it is single-issue non-planning and does not account for needed green infrastructure. It never accounts for the urban forests, it never accounts for parks, when Sacramento talks about putting housing in and changing zoning. You do not get good planning that way and we eat up what is left of the open space that we have, and the livability of our cities, our ability to adapt to climate, which is the urban forests.

Assembly Member Bloom noted that some of the things they do in Sacramento to change zoning have been popular and not despised as much as some of the housing bills that came down the pike in the last year or so. One of those bills was his, which reformed laws around building of ADUs, which has proven to be very popular with most of the people that they hear from.

Assemblyman Bloom continued that, in an effort to make the world more perfect, he had a bill three years ago that reformed the process for allocating the <u>Regional Housing Needs Assessment and Allocation</u>, coming up with a more realistic target for each city in terms of the amount of housing to be built, where they say you need to build "X" number of houses over the next eight years, you figure out how to do it and not told how to do it.

Board Member D. Loze agreed with Dr. Longcore's comments, and stated that there are many of us here who have been involved with our planning since a State Legislator told us in AB 283 that we had to make Community Plans and we have made Community Plans. He appreciates that Assembly Member Bloom has excluded high fire danger area but wants to send a message that we don't need guys in Tiburon telling us how to run our city and thanked him for his efforts.

Board President Greenberg thanked the Assembly Member for coming tonight.

Project: Mr. Sheagley noted the project is to replace existing pipe with new pipe: 550-foot section; 36-inch diameter; with welded steel pipe. They aim to improve liability and minimize community disruptions. Location: The 550-foot construction route along Sunset Blvd. begins at Marymount High School, 300 feet south of Marymount Place; continues north on Sunset to approx. 20 feet east of Udine Way. When: Starts November/December 2020 and ends May 2021.

Hours: Monday through Friday, between 7:00 a.m. to 4:00 p.m. Occasional work on Saturdays. Preliminary Traffic Layout: At least one lane will be available in each direction. LADOT will determine traffic arrangement; they are evaluating if a turn lane can be accommodated.

Community Concerns: LADWP will ensure proper driveway access, will mitigate noise and dust during construction and water service will continue during construction. They are working with roughly five houses on Udine and with Marymount.

- A brief Q&A followed, with questions regarding noise issues, note on restrictions with excavation and with regard to traffic along Sunset. [Deborah Hong later sent an email noting that more than 90% of UCLA's student and staff population and 75% of Marymount students will be online. They expect reduced traffic.]

#### ii. **Temescal Canvon Pole Replacement Project:**

Art Johnson, LADWP Transmission & Distribution Division Manager Arthur. Johnson@ladwp.com & Albert Van Styk, LADWP Transmission & Distribution Division Supervisor Albert.VanStryk@ladwp.com Project: Deborah gave brief presentation on this project. LADWP is to replace approximately 220 wooden power poles in the canyon along Mulholland Drive with construction west of the 405, north of Brentwood close to Encino area: Mulholland Drive between Greenbriar Drive East to Encino Hill Drive & Temescal Fire Road between Mulholland Dr. to Split Rock Trailhead as well as Encino Reservoir North to Mulholland Drive.

Deborah Hong related that the poles were installed from 1935 to 1955 and need to be replaced. They plan to replace wooden with weathered steel poles, 50-65 feet tall, more resistant to wind and fire, and will meet new PVC standards. The poles are located in rugged terrain. MRCA and Coastal Commission as well as City of LA have jurisdiction. They began work in 2019, when it was discovered that there was a federally-endangered plant species growing in the canyon. Construction came to a halt and they have been working with the agencies on a plan to mitigate the plant species and continue with construction. They are meeting with three agencies, looked at a variety of alternatives from moving the poles, some suggested undergrounding poles, which would have an incredible environmental impact. They are now ready to go to the California Coastal Commission meeting in November with a plan to mitigate the plant species and with the construction proposal to install the new steel poles. They are asking for support for when they go to the Coastal Commission. They will have a three-day board meeting; all virtual now, and have a public comment period.

Deborah Hong introduced Art Johnson, Manager in Construction & Maintenance Division, working on this.

BABCNC Open Spaces Representative Dr. Longcore asked regarding raptor electrocution prevention devices illustrated on one of the poles, noting that this is one of the major risks of power poles through wild lands: raptor electrocutions or bird electrocutions that then start the fires, with flaming bird on the ground after getting electrocuted. He asked will all poles be treated with anti-electrocution guards and if not is there a method to determine which ones should and shouldn't be treated? Art Johnson responded that every pole will have raptor guards installed with insulation to the steel pole, which will protect raptors and they have construction standards upgraded in those areas, so that the conductor spacing is a lot wider than usually seen in the city.

Dr. Longcore asked what their mitigation plan is for the Braunton's Milk-Vetch. Deborah Hong responded that the Coastal Commission is reviewing the plan, to include collecting seeds, propagating plant chains, depending on the areas identified. They have a plan for mitigation, restoration and construction. Deborah will get more details on the mitigation plan.

BABCNC Traffic Committee Chair Sandler asked if the public's comments will be considered by the Coastal Commission at that late date or will there be something earlier so people could comment. Deborah believes that once this goes to the board, they present the matter. Topanga State Parks will also be present and she believes the board will make their decision. President Robin Greenberg thanked Deborah Hong.

- 20. <u>Motion</u>: That the Board submit a Community Impact Statement expressing support for Councilmember Ryu's motion, in Council File 20-1170, introducing legislation to pause construction in fire-prone hillsides. Congestion related to construction on our narrow hilly roads can severely impede access for and to many of our residents, leaving these residents dangerously far from help in the event of a fire or other emergency.
