## A. Proposed changes in the BABCNC By-Laws and Standing Rules:

1. Changes in board structure, i.e.: removal of non-participating associations and replacement by "At Large" members who will be appointed by the president approved by the board until the next election.

2. The change in committee chair election process.

3. The minimum number of HOA members to qualify for a board seat and removal of those existing associations that don't meet that criteria.

4. Posting requirements are a minimum of five and must follow Brown Act requirements. Modify existing posting locations. Actual places to be contained in the Standing Rules.

5. Removal for failure to attend BABCNC Board meetings (Suggestion is four unexcused absences in one year)

6. Removal for failure to take ethics exam and or required "continuing education" (goes into effect July 1st) 60 days to comply and no voting privileges or chairing of a committee, if applicable.
