# Call to Order (Agenda Item #1)

# **Update on pending expenditures** (Agenda Item #2)

Alan commented on the pending payment from DONE for the reimbursement of \$2,500 used to purchase equipment for Fire Station 99. He will follow-up with Deanna Stevenson.

Fire Stations 71 and 237 have not started their respective projects.

A motion to give up to \$5,400 to the LAPD – Hollywood Division for 2 exercise treadmills will be brought to the entire Council at the April Meeting.

Alan made a motion to hire a geologist for a one-time service of up to \$1,000 for the 1400 Linda Flora Project. Robert seconded.

David commented that Gary Gole asked for clarification weather or not DONE allows such expenditures.

Steve Twining commented that Deanna Stevenson has commented numerous times to the Council that such expenditure is allowed. He referenced the hiring of Scott Malsin for his services for the website.

Alan concurred with Steve's comments.

Robert stated this is Pilot Project and that if the need for more projects comes up, a template would be created to make a request to the Council to continue such a continuing Program.

Robert also stated that expenditures of up to \$1,000 do not need Board approval and can be made at the Executive Committee.

# **<u>Review projected Expenditures</u>** (Agenda Item #3)

Alan briefed on the request for a donation to support the Caring Adults Teaching Children How Mentoring Program (CATCH) sent by Pam Marton. The Council is not allowed to give donations. Irene commented that the Magnet School needs lights in the parking lot and asked if the Council could look into assisting.

David will contact Pam Marton to see if such a need exists.

Robert commented that community leaders need to approach the Council with requests for funds since they know the needs of their community.

Irene commented that a Book Drive might be an ideal project in the future.

# Administrative Assistant Report (Agenda Item #4)

David briefed the committee on the Fire Day sign up. There are five volunteers so far, though the location may change per Chuck Maginnis' e-mails.

Steve commented that he would like to see Fire Station 41 as the site for the Council to be present and stated the need to update the BABCNC newsletter.

Robert asked that David work with him on drafting a President's message.

Irene commented that each committee should give a brief update for the newsletter.

Alan briefed the committee on the proposed budget for 2008-2009 and will bring a motion before the Council to approve.

Alan briefed on the request by Crests Neighborhood Association to change their name to Beverly Crest. David commented that the Council could opt to have a public hearing or send a letter to the City Clerk in support of the name change.

Robert Ringler directed David to draft a letter in support of the name change and send to the City Clerk's Office by the appropriate deadline.
