Hi,

I hope this email finds you well.

As you might already know that the City Council and the Board of Neighborhood Commissioners (BONC) was able to approve a Resolution for Neighborhood Council Leadership Orientation that will require Neighborhood Council Board Members in the Planning and Land Use Committee (or its equivalent) to complete a "Planning 101" training being held by the Department of City Planning in order to be eligible to vote on motions on planning, zoning, or land-use matter before the Committee to send to the Board. We are still clarifying some questions like the enforcement or how to track the members that took their training.

Below is the Resolution language and the forwarded email from the Department of City Planning with such training opportunities for YOU to complete as soon as possible. I invite all board members to take that training to be more comfortable to make a decision or identifying important matters to you when a planning or land-use item comes to the board.

Resolution for Neighborhood Council Leadership Orientation (Selected Language) :

2. The "Planning 101" Training, under development by the Department of City Planning, shall be required for all appointed and confirmed members of each Neighborhood Council's planning and land use committee, or an equivalent committee (land use committee). Any individual who does not complete the training shall not be eligible to vote on motions or recommendations on planning, zoning, or land use matters before the land use committee. Upon launch of Planning 101 Training, any land use committee member who wishes to continue serving on the land use committee must complete the training within 60 days of the launch. Thereafter, any individual who intends to serve on a land use committee must complete the training within 60 days of appointment or confirmation. An individual who fails to complete the training within the applicable 60-day period will be automatically ineligible to serve as a member of the land use committee.

Thank you for your help and consideration on this matter and I hope you register for this training.

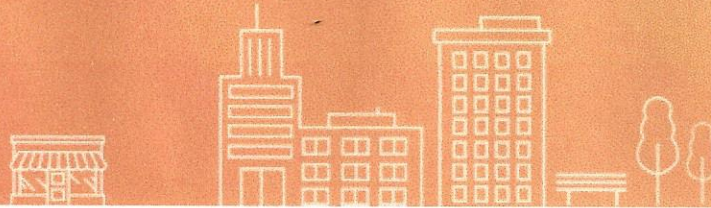

Registration is still open for City Planning's *Planning 101* online training sessions. We're excited to see that over **1,900 individuals have registered already!**

The annual *Planning 101* series provides a general overview of the core functions of planning in Los Angeles and serves as an educational and practical resource for anyone interested in learning more about how land use policies are created and implemented. This year's *Planning 101* series consists of two presentations, one on project planning and one on community planning. Each presentation will be offered several times, but the content will remain the same each time.

In keeping with Mayor Eric Garcetti's Safer At Home orders, this year's training will be offered virtually to minimize and stop the spread of COVID-19. Attendees will be able to join by telephone, or remotely, through GoTo video conferencing software.

Project Planning Sessions

The Project Planning training will highlight how projects are reviewed and walk attendees through each step of the development review process—beginning with the submission of a project application at the public counter and ending with the approval of a building permit.

Launched in 2017, the *Planning 101* series is an educational initiative led by Los Angeles City Planning that provides the public with an overview of basic elements of the City's planning and development process. Over the last three years, about 30 trainings have been attended by more than 1,500 community members, including students, residents, neighborhood council members, members of community-based organizations, and planning and policy professionals.
