- 5. <u>Discussion & Possible Motion</u> Sort and approve questions submitted for the upcoming town hall on the Skirball Fire scheduled for January 31, 2018 7:00-9:00pm at Franklin Canyon's Rosenfeld Auditorium

<u>Speakers</u>: Paul Koretz, David Ryu, Greg Martayan, Armando Hogan, Chris Ragsdale, Neighborhood Prosecutor, Veronica de la Cruz, Walt Young, Michael Schlenker, Tom Waldman LAHSA, VaLecia Adams of St. Joseph's. [The City Attorney's representative on homelessness issues wasn't available; she recommended the Neighborhood Prosecutor, Veronica De La Cruz.] Robin a formerly homeless man, Mr. Albert Muto, spoke at PPCC. She invited him & Maryam Zar of PPCC.

Possible questions discussed, included but not limited to:

- How will the various entities of the city deal with brush clearance?
- Tony asked about "Arson Watch"
- If there's an evacuation, who gets that notice out to the people and how does that happen?
- Who notifies WAZE during Evacuation Plan?

- Ron mentioned LAFD-ACS – The L.A. City Fire Department's Auxiliary Communications Service (Michael Schlenker serves on) which communicates with LAFD on High Fire Days, & HCEC – Hillside Emergency Communications group which ties hillsides from Laurel Canyon, Northridge, Palisades and Westwood.

- How does one get information as to shelter in place areas?

- As to notification, if you can't use your television, is there a platform that everyone can be notified by?
- Ron suggests having monthly alerts using the system Michael put in place; "this is a test, this is a test."

Goals: Having a communication system.

- What is the clear line of communication in case of an emergency?
- Does the city have a liaison with WAZE and Google?
- Ron noted that in any disaster, it all comes down to communication / the lack of coordinated communication.
- We need to have an emergency number; a direct line of communication and emergency updates.
- Tony suggested asking for a singular platform for communication from the city incorporating all platforms;
- He asked for help making sense of all these motions & how are we combatting homeless? Time frame?

- There was discussion as to brush clearance. Tony would like to see the LAFD work with entities such as Urban Forestry as to what to clear, etc.

- 6. <u>Discussion & Possible Motion</u> a) To ask representatives of BABCNC to see if their constituents will allow lawn signs for the entrances and exits of their respective districts (to let neighbors know we exist); b) To ask the Board to spend some outreach funds to order lawn signs for this purpose. <u>Motion</u>: to approve funds not to exceed \$500 for lawn signs and riders for outreach events. <u>Moved</u> by Tony <u>seconded</u> by André, <u>6/0/0</u>; <u>passed</u>.
- 7. <u>Discussion</u> To clarify plans for Clean Blight in the Hillsides of the BABCNC territory. Deferred.
