- **<u>2.</u>** <u>Motion</u>: Approve October 21, 2019 Outreach Committee meeting Agenda. Moved by André, seconded by Maureen, passed unanimously

 - b. Utilizing more social media (1 really meaningful post per month) & regular posting of event information (double following on all social media)

 - d. Getting more web traffic on our site Moved by Ellen seconded by Andre, passed unanimously
- 7. Discussion & Possible Motion: Assess committee bandwidth. Discussion was held. André will write some pieces. Maureen will work on getting bios of board members for the website.
- **8.** Discussion & Possible Motion: Review current assets (Attachment B), possible tools (website, mailing list, social media, events, outdoor advertising, etc.) and associated expenses to begin to match priorities with potential activities. Discussion of current assets was held.
- 9. Discussion & Possible Motion: Discuss how to streamline process for creating social media posts. Motion: Board members who would like something posted to social media will go through Ellen, Robin or Jamie. If any other board members wish to be able to post to our accounts, they should contact the Outreach Committee. Moved by Ellen, seconded by Maureen, passed unanimously.
- <u>10. Discussion & Possible Motion</u>: Downgrade our Mailchimp account to a free account for a savings of ~\$240/year. <u>Motion</u> To return to a free account for Mailchimp. Moved by Ellen, seconded by André, passed unanimously.
