The public may signal that they will make public comment by clicking the ‘raise hand’ button via Zoom or by dialing *9 (if joining the meeting via telephone) to ‘raise hand’ when prompted by the presiding officer. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Committee’s jurisdiction will be heard during Agenda item #6, General Public Comment period. General Public Comment is limited to one (1) minute per speaker, and 15 minutes total, unless adjusted by the chair of the committee. Public Comment under any agenda item is also limited to one (1) minute per speaker.

8. Metro Express/Toll Lanes I-405 Sepulveda Pass ExpressLanes

(This is not part of the Sepulveda Transit Corridor Project)

At its 09/13 meeting, the BABCNC Traffic Committee discussed the Metro project, in which Metro is evaluating alternatives to convert existing high-occupancy vehicle (HOV) lanes to dynamically-priced, high-occupancy toll (HOT) lanes, also called ExpressLanes, in the southbound & northbound directions of the I-405 Sepulveda Pass, between US-101 & I-10. The committee voted to reject the proposal for the toll lanes and to write a letter detailing the reasons why.
