Generally, it was believed that LAPD was responsible and best-equipped to respond to "events" and that doing so in relation to the party house ordinance was the only real means of enforcing against events. There is no other effective mechanism for responding to events occurring without proper precautions or required permits and no governmental body willing to do so despite the existence of rules and regulations that would seem to apply to events. If an event presents a fire danger, asking for the fire department to be dispatched was advised.
