4/27/2022

- **Wildlife Linkages**

Co-introduced along with our other Rim of the Valley partners (including CM Koretz) [CE 22-0483](#) a motion to direct our City agencies to coordinate with other jurisdictions for habitat linkages as well as to get a report back on or before P-22 Day this year, 10/22/2022 with a plan on the expansion of the Wildlife Ordinance to cover additional Protection Areas for Wildlife

- **Wildlife Ordinance**

City Planning has consolidated the Wildlife Corridor Study and the Ridgeline Protection Ordinance into the [Wildlife Ordinance](#). A [revised version](#) of that ordinance is out now. A map of the proposed Draft Ordinance area is [here](#).

- **Homesharing Motion**

Our Homesharing Motion ([CF 14-1635-S10](#)), co-presented with CM Koretz is up at full City Council this Friday, April 29th. Agenda [here](#). This is asking for a Report back from City Planning and other agencies on needed reforms for the Homesharing Ordinance. This motion owes so much to the work of DSPNA and BABCNC and your constituents who helped bring issues to our attention.

- **Emma Taylor joined as our District Director**

She comes to us from Assemblymember Adrin Nazarian's office, where she served as District Director

- **Mulholland from Laurel Canyon to Wrightwood being resurfaced in early May (projected for the 7th and 8th as of now)**

- **I met with some neighbors down by Mt Olympus and submitted a number of maintenance items and safety requests for LCB**

- **We have been engaged on the budget and trying to get dedicated traffic enforcement resources for the Hillsides. This is especially important for Wonderland as we have been continually been told "no" by LADOT for staffing.**

- **Real Time Interpretive Services Motion**


Introduced a [motion](#) on the 13th for a 60 day report back motion for expanding real time interpretive services for City Council.

- **Building Decarbonization Motion**

Building [Decarb Motion](#) has been introduced and we're still moving through. All new residential and commercial buildings. Passed through PLUM and has to go to the Economic Development Committee

- **Council voted to approve our motion to establish a permanent Office of Procurement for the City of Los Angeles** within the office of the [City Administrative Officer](#). The creation of a permanent Office of Procurement will not only ensure higher standards of bureaucratic excellence, improve efficiency, and reduce costs. It will also enable us to treat procurement as an area of strategic policymaking, and use our City's spending to advance important social and environmental goals.
- **We made huge strides on our [Encampment to Home project](#) at the Cahuenga / 101 underpass.** Last year, we secured \$1.2M to support this effort and **we have now brought 39 people indoors into interim housing.** This builds on our work getting dozens of people indoors from encampments in the Valley, including at underpasses at Coldwater/Van Nuys Blvd and at Fruitland/Ventura Blvd. With all of these individuals, our focus is to work with housing providers to move people into permanent housing placements. Our work in the district continues to show that when we can secure the housing resources and the funding, we can really make incredible progress in addressing our homelessness crisis.
- With the deadline to apply for the state's Emergency Renters Assistance Program (ERAP) on 3/31, our team **knocked on 1,200 doors and had over 120 conversations with renters**
- Knowing just how vital rental assistance is in keeping people housed, we didn't stop at door knocking. Our team mobilized a virtual text bank and **sent 24,000 text messages to CD4 renters!**9) We also [introduced legislation](#) to upgrade the City of Los Angeles' **Rent Registry** so that it can more effectively prevent illegal rent increases and evictions and provide tenants with important housing resources. These improvements can help our City to fulfill its promise to proactively monitor and enforce the rules and regulations provided under the Rent Stabilization Ordinance.
- **Planning will be opening DSCs for appointment-only. Vax or negative COVID test within 72 hrs needed**

On Monday April 18, EWDD is launching the [City of LA's Small Business Rental Assistance Program](https://ewddlacity.com/index.php/recovery/rentassist), which will provide **\$12 million in grants to eligible businesses** located in the City that need financial assistance to aid in their recovery from COVID-19. Grants will be of up to \$15,000 or six months of back rent, whichever is less. **Applications are due May 2.**

The grant may be used for rent payments that are in arrears that were incurred on or after March 1, 2020. To be eligible, businesses must be for-profit and have a brick-and-mortar storefront location located and operated within Los Angeles city limits. Businesses must also provide lease agreements and proof confirming that back rent is owed.
