4) Please describe the purpose and intent of the grant.

The Purpose of this grant is to provide funding for the completion of the CAD drawings and/or permits for the medians and other traffic calming devices on Beverly Glen Blvd., between Greendale and Scenario Lane.

These measures have been proven to slow traffic, provide animal and pedestrian refuge, prevent dangerous passing, beautify the neighborhood, increase property values, and will pay for themselves when you consider the high costs of the numerous accidents on the street.

How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

Beverly Glen between Greendale and Scenario Lane is a residential area that has become increasingly dangerous over the years, as evidenced by numerous accidents. Speeding on the street is out of control. It is hazardous for residents to enter and exit cars safely. Paul Koretz and his office, as well as Tim Fremaux from West LA traffic have suggested installing medians similar to Outpost Lane to help the situation. Councilperson Koretz's office has donated \$2,000, and has just applied for a Federal Grant last month and will apply for another one in May. Initial drawings have been completed and a Class B Permit is under way.
