For those of us east of Beverly Glen imagine coming up the hill from the valley and trying to make a left from Beverly Glen onto Angelo waiting for a gate to open.

In addition, any time those east of Beverly Glen want to go to the valley we will need to deal with two gates on Angelo. How will

this help our community? Some community members have thought, "well why not just gate our east side too."
