I would like to express my deep concern regarding the potential purchase of AJU by EF. The AJU campus, which served Rabbinical students from inception was a quite and well run organization that did not detract from our neighborhood, however EF is a for profit multi-national corporation that wants to increase revenue cost by filling the campus to the brim with students, and then shuttling in several hundred more each day!

These international students have no local markets, restaurants or entertainment that is walking distance from the proposed campus, therefore a massive amount of infrastructure will be brought into the area on a daily bases to feed them, as well as transport them off campus. The increase in cars and busses will not only cause a huge bottle neck on the corner of Casiano and Mullhullad, but will also negatively impact all the school busses who use this area as a staging ground to pick up and drop off kids from the neighborhood schools, as well as prevent parents from dropping off or picking up their children from Stephen Wise Religious Day school.

In addition, they will prevent home owners from being able to use the ONLY entrance and exit that we have for our community. The two lanes that come into and leave Casiano are our only access to emergency service, and exit in case of fire evacuation.

I cant imagine what adding almost two thousand more people including students, staff and maintenance, which is being proposed by EF would have done during our last fire evacuation only a few years ago. This is a bad idea, poorly conceived and will negatively effect our community in many direct and indirect ways.

Please do not accept EF's claims, read their negative reviews, come to our neighborhood and see for yourself how their plans will not fit into a

neighborhood such as this. I beseech you to vote against this request to expand the number of on campus students and their proposal.
