I am out of town. But please consider the resolve outlined in this email regarding No Turn signs.

All that is needed is-

1 sign at Briarwood- saying " Be Advised NO Right Turn on Angelo / Beverly Glen M- F 4-7 pm

This would still allow homeowners access and the use of the public park on Almaden.

1 sign at Nicada / Beverly Glen at the entrance of Bel Air Glen HOA to read: NO Right turn on Angelo to Beverly Glen M-F 4-7 pm.

Then 1 sign on Angelo/ Beverly Glen facing onto Angelo- NO Right Turn M-F 4-7pm

Monitor needed ONLY at Angelo - as the goal is to mitigate the cut thru traffic for both HOA's on this side of Beverly Glen!!

People get a ticket once will never do it again.

This will make almost 300+ homeowners able to enjoy less honking , less Pollution and safety on our 1 and 1/2 public streets. As the rest of our streets are Private.

Regarding across Beverly Glen to Bel Air Ridge-
