Dr. Longcore provided welcoming comments and information on conducting the meeting virtually, per SB 411. He called the meeting to order at 7:05 PM. Following the salute to the flag, roll was called with quorum met. There were 26 members present initially. Member Barcohana arrived at 7:20 PM, for a total of 27 present. Member Wickers at 8:15 PM.

Prior to going to agenda item #1, Dr. Longcore noted that an issue arose today on item #8 (Stanley Hills project), he needs advice from the City Attorney on it, and is recommending we *not* hear that item tonight until he gets advice. He noted that means while there were folks here to speak on that item, it is now not on the adopted agenda tonight. He welcomed people to give general public comment but we will not be hearing #8 tonight.

1. The Agenda without the item #8 was **approved**.
2. The October 22, 2025 Meeting Minutes (Attachment A) were **adopted** as **moved** by Stojka, with **one abstention** from Templeton.
3. **General Public Comment**
BABCNC welcomes comment from the public on any topic within the Board's jurisdiction but not on the adopted agenda.

Sandra Carradine asked for clarification on why we are not hearing Agenda item #8. Dr. Longcore reiterated that he is awaiting some guidance from the City Attorney. When it comes back, it will come back to the agenda. All comments go with the file.

Valentina Palermo spoke in opposition to the Mulholland Tennis Club project as regards changing their 1964 CUP restrictions. She read a prepared speech (hear on the recording), and noted that she has collected 56 signatures of opposing efforts to change the rules and conditions in place.

Eoin McCarron noted that he represents Valentina in connection with the Mulholland Tennis Club, and explained that the club has been causing a nuisance to Valentina and some of her neighbors, and detailed their concerns about the proposal.

Claire Willenson was called but was unable to unmute. Dr. Longcore noted that we can come back to her.

4. **Updates from Elected Officials and Agencies**

Amanda Laflen from the Office of Supervisor Lindsay Horvath - Amanda thanked Robin, Maureen and Bob for having a table at the Supervisor's Emergency Preparedness event last Sunday. She noted that ours was the only NC from CD4 11 or 5; however, they had 150 people come through, and gave away 115 weather radios and reaching a lot of people. She thought it was a very successful event and thanked us for our support. Robin thanked her. She provided a brief update on the Board of Supervisors, who approved a bill under SB782,

Walker King from Office of Councilmember Nithya Raman CD4 filling in for Sidney Liss provided an update for CD4 including but not limited to legislatively expanding the Unarmed Model of Crisis Response (UMCR) in Los Angeles. Right now, those are operating

in some parts of CD4 but not in all; he didn't know if there are any in the Bel Air-Beverly Crest area. He invited us to let them know what we need. He spoke on the Rent Stabilization Ordinance, happy to be expanding rent protections, and noted it remains to be implemented. He spoke on the City Charter Commission survey.

Member Hall thanked him and Mashaël for connecting us with the Mayor's office. Member Kamin followed up on the UMCR, noting that there was an interesting June 25, report from the city CAO about significant barriers to that project. Walker responded as to the issue of where to find the funds for that. Kamin noted the recommendation of any money that can be found to get directed to the call centers.

Claire Willenson did not respond after being called again to give public comment.

5. President's Report

President Longcore spoke on the upcoming in-person meeting on December 17, 2025 at TreePeople which will include a meet and greet pot luck dinner and a moonlight walk to the memorial honoring the late great BABCNC Board member, Donald Loze. There will be an email coming asking for what you will bring to the potluck.

He noted the importance of us getting together and seeing the plaque. He thanked Robin and everyone who volunteered their time at the EP fair that was greatly appreciated. Vice President Greenberg thanked the following individuals for being there: Members Levinson, Smith, Mann, Marburg, Levotman and Weinberg.

6. Monthly Expenditure Report

Project Description:

Construction of a new SFD with a two-car garage.

Requests:

Allow construction of a new SFD in R1 Zone on a substandard hillside street without improving otherwise required Continuous Paved Roadway of < 20 feet.

Motion: BABCNC opposes relief from code requiring a 20-foot wide continuous paved roadway on the grounds that the required findings cannot be made because:

- BABCNC has received testimony indicating that the project would pose a hazard to the surrounding neighborhood as a result of demolition of the previous structures without proper asbestos handling and disposal and asbestos remains unabated at the properties.
- Without 20-foot roadway access, additional development at the site, which currently has no legal structures, would adversely affect and degrade the safety of the surrounding neighborhood, while presence of unabated asbestos endangers public health,
- Proposed grading has the potential to destabilize retaining walls that span from the subject properties to an adjacent property, making the development materially detrimental or injurious to adjacent improvements: and
- Approval of the project would violate California Minimum Fire Safe Regulations that preclude development of a site without a current structure unless the 20-foot continuous paved roadway is provided.

Sami Kohanim asked about the recusal and why we were not hearing this tonight. He was told that we will have to take it up another time. Rouzbeh Zarrinbakhsh asked further.

9. **Zone Zero Fuel Modification**

Motion: BABCNC supports the position of the City of Los Angeles regarding the statewide imposition of a vegetation-free zone within five feet of all structures in the State-designated Very High Fire Hazard Severity Zone and will file a Community Impact Statement in Council File 10-2468-S2.

Dr. Longcore shared his presentation, and following brief discussion, Greenberg called the question. Member Stojka would like to share this with his association. Dr. Longcore noted that it is being recorded but there is a YouTube video that he gave to LA Audubon.

The motion passed 24-0-2, with the abstentions from Templeton and Longcore.
