- 7. Discussion and Possible Motion:** Many hillside substandard streets are erroneously identified by BOE as being 20 ft wide. Actual width of these streets varies but is often less than 20 ft. Unless the street width is verified, many projects will fail to obtain required discretionary approvals. **We propose the following:** 1 - Permit applicants shall be required to pay for simple investigation by BOE to verify hillside street width. 2 - BOE corrects erroneous data on Hillside Referral forms. 3 – With support from CD4 and CD5 we shall petition BOE/CA office to implement corrections. 4 – Request that BOE improves personnel training and follows their own already established procedures
